Housekeeping

If planning to offer oral testimony

1. Access the event via Webex, and
 2. Use the **identical** name as used when registering, and
 3. Select audio options:
 - Have WebEx call you, or
 - Call via phone – if using this method you **must** enter your **Attendee ID**, which is located in a pop-up that appears when selecting the phone option
- All attendees will be muted upon entry into the event
 - Your line will be unmuted when it is time to speak
 - Each speaker should state their name, and if speaking as a Tribal leader or Tribal leader designee, their title and the name of their Tribe
 - Oral testimony for speakers that are not Tribal leaders will be limited to 7 minutes.

Locate WebEx Features by mousing over on the bottom center of your screen to see the Media Viewer  and Chat  icons.

Live-captioning is available for deaf or hard of hearing individuals. Please click on the “Media Viewer” to log in.

Missing Person Cases

- **Scope**
 - Gender, age range, on or off tribal lands?
 - Are reports to law enforcement generally made?
- **Challenges**
 - Are any protocols in place?
 - Coordination; information sharing?
- **Solutions/Resources**
 - How to reduce vulnerability?
 - Coordination; information sharing?
- **Recommendations**
 - Specific recommendations?
 - What federal resources are needed?

Murder Cases

- **Scope**
 - Gender, relationship of victim and perpetrator?
 - Law enforcement investigation/prosecution?
- **Challenges**
 - Investigation/victim/family services?
 - Coordination/information sharing?
- **Solutions/Resources**
 - What resources does your community have?
 - Major strengths and assets to share?
- **Recommendations**
 - Specific recommendations?
 - What federal resources are needed?
